NORDSCI Terms and Conditions of Attendance and Participation www.nordsci.org

These Terms (the "Agreement") are governing your attendance at and/or participation in a NORDSCI Event (the "Event" and/or the "Organizer") in any of its participation forms and/or publishing in NORDSCI Conference's Proceedings.

By registering for the Event, in all kind of its participation forms, you are agreeing to these terms, which form a legal contract between NORDSCI and the registered attendee and/or participant ("you"). If you are registering on behalf of another it is your responsibility to ensure that the person attending is aware of these terms and accepts them, and by completing the registration you are warranting that you have made the attendee aware of these terms and that they have accepted these terms.

1. Event admission

- 1.1. Admittance. Your registration entitles you to admittance to the Event. Any and all other costs associated with your attendance (including without limitation any travel and/or accommodation expenses) shall be covered solely by you and the Organizer shall have not liability for such costs.
- 1.2. Termination. You acknowledge that the Organizer reserves the right to request your removal from the Event if the Organizer, in its sole discretion, considers your presence and/or behavior to create a disruption or to hinder the Event and/or the enjoyment of the Event by other attendees or lecturers.
- 1.3. Media. - 1.6. Any of the participation forms can be closed or limited for registration at Organizer's solely decision.
- 1.7. By registration for the Event for any of its participation forms, you declare that all the provided information is correct. In case of presenting incorrect information, you're solely liable in the responsible courts.

2. Fee(s)

- 2.1. Payment. The payment of the applicable fee(s) for the Event is due upon registration. If such payment is insufficient or declined for any reason, the Organizer may refuse to admit you to the Event and shall have no liability in that regard.

3. Cancellation Policy

If your cancellation is submitted within 10 calendar days from the date of your payment, but no later than 30 days before the start of the event then: There will be a 50% refund of the total amount; All refunds will be made by bank transfer to the account of the initial sender. - 3.4. If the cancellation request is submitted up to 30 days prior to the start of the event, the amount is unrefundable. However, substitutions (subject to availability) may be arranged at the sole discretion of the Organizer.

4. Abstract and Paper Withdrawn

- 4.1. In case you need to withdraw your paper abstract, but the paper abstract has been reviewed and accepted by the Review Committee and you have received an Official Confirmation Letter, there is a Review Service Charge of 20 Euro per paper.
- 4.2. In case you need to withdraw your paper abstract, but the paper abstract has been reviewed and accepted by the NORDSCI Review Committee, you have received an Official Confirmation Letter and the article title is already included in the Conference Programme (published on the web site) and the paper has been forwarded for pre-print, there is a Review Service Charge of 30 Euro per paper.

5. Privacy policy

5.1. NORDSCI Conference is part of Saima Consult Ltd and is committed to protecting the privacy of its customers. The Organizer operates a strict privacy policy, which is available at NORDSCI's web page www.nordsci.org, accessible anytime.

6. Intellectual property

- 6.2.
